#### Executive Board Update

The ASN Executive Board met in late September and discussed a number of important items. We identified a need to enlarge the Board and provide broader opportunities for participation in ASN governance activities. Doing so will require analysis of the existing ASN bylaws and a vote of the membership in the coming months.

#### American College of Nutrition

In June, the ASN Executive Board authorized discussions regarding ACN's interest in a closer partnership or possible merger with ASN. A joint task force with representatives from both organizations was formed to examine the potential of an ASN-ACN relationship. The ASN Strategic Oversight Committee (SOC) completed a review of findings of the joint task force, and the ASN Executive Board reviewed the recommendations and approved moving forward. ASN and ACN have now entered into a formal agreement for the transfer of ACN operations and assets into ASN. A transition group will provide guidance as the ACN members and programs are incorporated into our Society. Nutrient Information articles are concise summaries providing information on food sources, diet recommendations, deficiencies, toxicity, clinical uses, recent research and references for further information for micro- and macronutrients.

Agency reports are summaries of reports and other relevant documents available from agencies such as IOM, USDA Food and Nutrition Information Center, NIH Office of Dietary Supplements, and others.

To ensure that a topic is of interest to the Editorial Board and that a review dealing with the same aspect of nutritional science is not currently under review, potential authors are advised to contact the Editor, Dr. John Suttie (suttie@biochem.wisc.edu), and provide a brief description of the potential review topic before submitting a manuscript. All submitted reviews will be subjected to peer review before being accepted. Online content for the new journal will be made available to all 4,000 ASN members, as are The Journal of Nutrition and The American Journal of Clinical Nutrition. Advances will not assess manuscript submission fees, page charges, or charges for colored figures. To increase the impact and visibility of the new journal, all reviews published during the first year of publication will be available to all readers, regardless of their subscription status.
