Federal Policy for the Protection of Human Subjects

The highly anticipated [Notice of Proposed Rulemaking \(NPRM\) regarding Federal Policy for the Protection of Human Subjects](#) was released on September 2 by the Department of Health and Human Services (HHS), in coordination with other federal agencies. The proposed rule is the first action since the [July 2011 advance notice of proposed rulemaking](#) (ANPRM) to update the regulations governing human subjects in research, known as the Common Rule (45 C.F.R. Part 46). The [comment period](#) for this NPRM ends after 90 days, on December 7, 2015.

Congress Back with a Loaded Schedule

Congress returns after Labor Day with only 23 days in session until Congress is scheduled to adjourn for the year on October 29. In this abbreviated work period, Congress must vote on some very contentious issues - the multilateral nuclear agreement with Iran (by September 17), the Continuing Resolution (CR) for 2016 funding appropriations (by September 30), the federal highway bill (by October 29), and the increase of the debt limit. As for appropriations, despite the efforts of the House and Senate Appropriations Committees to report all 12 of the annual appropriations bills to the floor, not a single measure has been enacted. Senate Majority Leader Mitch McConnell (R-KY) and Speaker of the House John Boehner (R-OH) have expressed intent to avoid a government shutdown and seek passage of a CR without any policy riders attached, possibly at the current 2015 appropriation levels.

Action on Child Nutrition Legislation Expected in mid-September

The authorization for the child nutrition programs expires on September 30. Members of Congress have expressed their intent to approve a bill to reauthorize these programs, but only 10 days remain in September with Congress in session. Temporary extension of these programs has occurred many times before when Congress did not meet the reauthorization deadline. However, the authority for some programs such as the fresh fruit or vegetable snack program may not be covered in an extension.

In August, Rep. Vickie Hartzler introduced a bill [H.R.3307](#), the *School Lunch Affordability Act*, to keep school lunches affordable for families by eliminating federal mandates on school lunch prices and returning this authority to local school districts. Under the legislation, districts that fully cover the costs of their meal programs would be able to bypass a federal requirement that says they must increase the cost of meals.

Journal Highlights

Advances in Nutrition

The [September issue](#) of *Advances in Nutrition*, ASN's international review journal, features these review analyses:

- How can we best manage obesity among childhood cancer survivors? Zhang et al. believe that promoting family-based healthy lifestyles is a priority for preventing the early onset of obesity in childhood cancer survivors. They do caution, however, that nutritional intake in childhood cancer survivors has not been adequately examined.
- Why is it so difficult for some people to lose weight? Generally, humans seem to be better equipped to defend against weight loss rather than avoid weight gain, but results also show a large individual variability. Therefore, according to Clemens Drenowatz, individual differences rather than group means should be explored to identify specific characteristics of "compensators" and "noncompensators."

Vitamin B-12 deficiency can cause unsteadiness, behavioral abnormality, cognitive decline, and dementia similar to what is often associated with aging. As such, vitamin B-12 deficiency is sometimes overlooked until it is in its severe stages. Nonetheless, a newly-published randomized trial found no detectable benefits of vitamin B-12 supplementation in asymptomatic elderly study participants.
