



challenging and uncertain journey toward their PhD degrees. As the story unfolds, the interdependent mentor-student relationship reveals the human face of scientific research.

The film was shot over three years' time at Columbia University Medical Center and also documents how x-ray crystallography enables the discovery of the molecular structure of the AMPK protein, considered prime for targeted drug development because of its relevance to diabetes and obesity.

QUIZ: What was the "Citrovorum factor?" What was "factor M?" What was the *L. casei* factor? For answers to these and other perplexing questions plan to stop by the history of nutrition exhibit at EB2010. The two-part exhibit will illustrate aspects of the discovery of compounds with folate activity and, in its second part, items from the William J. Darby collection in the archives at the Vanderbilt University Medical Center's Eskind Biomedical Library. Please also plan to attend the history symposium on the history of the discovery of folic acid, its derivatives and their biological and clinical functions.

Have you stopped to think how young the science of nutrition is? 100 years ago E.V. McCollum was writing about the synthesis of "nuclein" in animals; he had not even thought about vitamin A. In fact, it would be another 3 years before Funk would coin the term "vitamines." Thus, we will have to wait another 3 years to celebrate the 100th anniversary of the vitamin concept. There has been a lot of progress in the science of nutrition in the intervening century, but clearly there is much more that needs to be learned.

HIAs are a flexible, data-driven approach that identify the health consequences of new policies and develop practical strategies to enhance their health benefits and minimize adverse effects. The Health Impact Project, a 4.5-year initiative that is funded by a \$7.2 million grant from RWJF to Pew to operate and administer the project, is accepting proposals for up to 15 HIA demonstrations ranging from \$25,000 to \$150,000.

HIAs are an effective way to incorporate health into the decisions made by sectors that do not traditionally focus on these outcomes-such as transportation, planning, education or housing. This strategy helps people lead healthier lives and creates healthier, safer communities. For example, an HIA for a new road could measure its impact on air quality, childhood asthma, and injury rates, then address them early in the planning process.

"To help people make healthier choices and stem the rising tide of chronic disease, health needs to be factored into public policy and other decisions that affect and influence how we live, work, learn and play," said Risa Lavizzo-Mourey, president and CEO of the Robert Wood Johnson Foundation. "The HIA process can foster a new way of thinking that puts health at the forefront of public policy."

"The project marks an exciting development in the evolution of our relationship with the Robert Wood Johnson Foundation," said Rebecca Rimel, president and CEO of The Pew Charitable Trusts. "This collaboration brings to bear valuable resources to establish health impact assessments as an essential part of the policy development process."

The Health Impact Project will fund government agencies at the local, state and tribal levels, nonprofit organizations, and educational institutions. Grants will be awarded on a rolling basis, and grantees will receive training, mentoring and technical assistance from the project and from leading HIA experts. When decision makers understand the health implications of a proposed policy, they can make better-informed choices that avoid unintended harm and unexpected costs," said Aaron Wernham, director of the Health Impact

Project and a leading national HIA expert. "We look forward to raising awareness about HIAs, and to working with many kinds of organizations around the country to help communities use this important tool."

A growing number of community groups and policymakers in the United States and around the world have begun to use HIAs to address a range of issues, including land use and transportation, housing policies, labor standards, natural resource extraction, education and economic policies. In San Francisco, an HIA for a new housing development resulted in several measures to protect residents from nearby roadway pollution. In Alaska, an HIA helped resolve a longstanding disagreement between community and government stakeholders and led to widely accepted revisions to oil and gas leasing plans, and several new protections for air quality and human health

The launch of the Health Impact Project is the beginning of an important collaboration between two of the nation's leading philanthropic organizations working to improve health and to serve the public interest. Scrimshaw International Nutrition Foundation, awarded at the 19th International Congress of Nutrition in Bangkok, Thailand.

March of Dimes honors Dr. Gail Harrison for outstanding work in maternal-fetal nutrition

PHILADELPHIA, NOVEMBER 9, 2009 – A nutritionist whose research was instrumental in adding fruits and vegetables to the federal Women, Infants and Children (WIC) food subsidy will receive the March of Dimes Agnes Higgins Award for outstanding achievement in the field of maternal-fetal nutrition.

Gail Harrison, Ph.D., MNS, , a professor in the Department of Community Health Sciences at the University of California, Los Angeles School of Public Health, will receive the award today at the annual meeting of the American Public Health Association (APHA) being held here.

Dr. Harrison is an internationally known scholar whose research – much of it in developing countries in Africa, the Middle East, and Latin America – has led to several important advances in maternal-fetal health. In the late 1970s and early 80s, her work proved that maternal obesity affects fetal growth. In 1983, Dr. Harrison was the lead investigator of a study in Egypt that demonstrated how the quality of a pregnant woman's diet influences the development and health of her baby and the nutrient composition of her breast milk.

More recently, as a member of an Institute of Medicine committee, **Dr. Harrison** conducted research that showed low-income pregnant women

are more likely to eat fresh fruits and vegetables if they receive specific food subsidies. That led to the committee's recommendation that fresh fruit and vegetable vouchers be distributed as part of the U.S. government's WIC program, which provides federal grants to states for food, health care referrals, and nutrition education. In 2008, WIC had more than 8,000,000 participants.

Dr. Harrison earned her bachelor's degree from the University of California-Santa Barbara, her master's from Cornell University, and her doctoral degree from the University of Arizona. She also served as the president of the Society for International Nutrition Research and has consulted with the World Health Organization.

Agnes Higgins was the longtime director of Canada's Montreal Diet Dispensary, a precursor of government nutrition programs for pregnant women in the United States. A pioneer in devising methods of nutritional assessment and counseling, she greatly advanced the understanding of diet as a crucial factor in healthy pregnancy and prevention of low birth weight. The award was created by the March of Dimes in her honor in 1980.

Data for over 140 food components (e.g., vitamins, minerals and fatty acids) are provided for each food item and is derived from USDA-sponsored laboratory analyses, food-industry data and the scientific literature. Approximately 3,000 new values for Vitamin D (naturally occurring and added) have been included and were used to prepare intake reports for the IOM panel reviewing the DRIs for vitamin D. Also included are nutrient profiles for 38 familystyle, Latino and Chinese restaurant foods. SR22 can be downloaded from NDL's website: www. ars.usda.gov/nutrientdata. In addition, the Dietary Supplement Ingredient Database, First Release (DSID-1), was made available at http:// <u>dietarysupplementdatabase.usda.nih.gov</u> on April

20. The DSID-1 was developed at the Nutrient Data Laboratory and funded in large part by the Office of Dietary Supplements/NIH. DSID-1 provides estimated ingredient levels derived from analyzed nutrient levels in a representative group of adult multivitamin/minerals (MVMs) consumed in the U.S. and enhances researchers' ability to investigate relationships between supplement intakes and health. **Donna Rhodes**, Food Surveys Research Group, was an invited speaker on dietary data collection in the U.S. and an ad-hoc member of the Expert Group on Food Consumption Data of the European Food Safety Authority (EFSA), which met in Parma, Italy on October 14-15. Alanna Moshfegh, Research Leader, Food Surveys Research Group, was invited to speak at a symposium on Evaluation of Food Intake to Conduct Public Policies at the XV Congress of the Latin American Society of Nutrition on November 17 in Santiago, Chile. A new report from What We Eat in America, NHANES 2005-2006 entitled "Usual Nutrient Intakes From Food and Water Compared to 1997 Dietary Reference Intakes for Vitamin D, Calcium, Phosphorus, and Magnesium" was released on the Food Surveys Research Group website at http://www.ars.usda.gov/SP2UserFiles/ Place/12355000/pdf/0506/usual_nutrient_intake_ vitD ca phos mg 2005-06.pdf. To develop this report, the vitamin D values were derived from the USDA National Nutrient Database for Standard Reference, Release 22, described above. Janet **Novotny**, Food Components and Health Lab, was appointed as a Scientific Advisor to the US Potato Board. David J. Baer, Research Leader, Food Components and Health Lab, was the invited keynote speaker at the Chinese Nutrition Society annual meeting on October 15 in Shanghai, China, where he spoke on his research with dietary whey protein and its role in maintaining a healthy body weight and preventing metabolic syndrome.

From the Children's Nutrition Research Center at Baylor College of Medicine... Teresa Davis presented an invited talk on "Amino Acids and Insulin as Regulators of Muscle Protein Synthesis" at the European Association of Animal Production in Barcelona, Spain on August 24. Dr. Davis also presented talks on "Regulation of Neonatal Muscle Growth" at the Rowett Institute of Nutrition and Health, University of Aberdeen on July 30 and "Developmental Regulation of Protein Synthesis" at AgroParisTech in June.

From Kansas State University...Two seminar speakers visited the Department of Human Nutrition. Eric Decker of the University of Massachusetts visited as a University Distinguished Lecturer and delivered two seminars: 1) "Delivery Systems for Incorporating Omega 3 Fatty Acids in Food Systems" and 2) "How to Incorporate Processed Foods into a Healthy Diet?" Dr. Chitra is Head of the Department of Clinical Nutrition and Dietetics at Kasturba Gandhi Degree and PG College of Women. **Brian Lindshield** was selected to be a Wakonse Fellow as part of the Wakonse Conference for College Teachers at Camp Miniwanca on Lake Michigan, June 2009.

From South Dakota State University... Teri **Kemmer** has designed and implemented a travel studies course to provide students the opportunity to learn about nutrition issues and assist in conducting anthropometric and biochemical assessments of children living in rural Honduras. SDSU faculty and students are working collaboratively with the Honduran Ministry of Health, Joint Task Force Bravo Medical Element, and the San Antonio Military Pediatric Center to complete nutrition assessments of children and provide nutrition instruction to families. The course is research focused and teaches team members how to conduct research in austere environments. A transdisciplinary team from SDSU is in the process of expanding KidQuest, a nutrition and physical education program designed by Becky Jensen, Cooperative Extension Educator. KidQuest education is targeted to 5th and 6th grade students within the classroom and incorporates school and family involvement. Londa Vander Wal, Project Manager, Food Safety, Animal and Plant Health, Food and Agriculture Organization of the United Nations (FAO) presented "Improving Health, Safety and Productivity of Women Vegetable Farmers in The Gambia" at SDSU on September 25. A new PhD degree in Nutritional Sciences has been approved at SDSU. Previously it was an area of emphasis in the Ph.D. Program of Biological Sciences. This is the first semester of the new and exciting program! Kendra Kattelmann is the principal investigator of a multistate National Research Initiative Competitive grant from the USDA National Institute for Food and Agriculture to develop a program for excessive weight gain in young adults. Co-investigators are from University of Rhode Island, University of Maine, Rutgers University, East Carolina University, University of Wisconsin, Kansas State University, Tuskegee University, Purdue University, and Michigan State. Ashley McCormick, graduated May 2009 from Nutrition, Food Science Hospitality Dept, SDSU, was selected to receive an Undergraduate Research Award at FNCE 2009 for her abstract titled "Fun Fruit and Veggie Event", which enhances acceptance of fruits and vegetables in schoolaged children. Minette Herrick, graduated May 2009 with a MS in Nutritional Sciences, received a

graduate research award at Society for Nutrition Education, July 2009, for her abstract titled "Characterization of Time and Order of Internet Lessons in Project WebHealth". Howard Wey, with the EA Martin Program in Human Nutrition, was an invited speaker at the Muscle and Bone Working Group Symposium at the American Society for Bone and Mineral Research. He presented a talk on the "Role of Lean and Fat Mass on Bone Accrual in Children Aged 8 to 18 Years".

She came to Grand Forks from Knoxville, TN, where she was an Assistant Professor of Public Health Nutrition in the Department of Nutrition. **Dr. Jahns'** research focuses on identifying behavioral, physiological, dietary, and biological causes and mediators of unhealthy eating behavior, inactivity, and unhealthy body weight in the American public, and to identify effective ways to facilitate and promote behavior changes in individuals and groups to meet dietary and physical activity recommendations for health. **She** has been designated to host the 34th National Nutrient Databank Conference in Grand Forks, ND, July 12-14, 2010. In March 2009, **Matthew** Picklo, joined the USDA/ARS Grand Forks Human Nutrition Research Center as Research Leader of the Micronutrient Absorption and Metabolism Research Unit. As Assistant Professor of the Department of Pharmacology at the University of North Dakota, his research addressed the roles of lipid peroxidation in health and disease with an emphasis on mitochondrial dysfunction. This work focused upon factors affecting metabolism of bioactive, lipid aldehydes derived from endogenous n-3/n-6 fatty acids, and their roles in cardiovascular and neurologic health. He is extending his work to address the health roles of dietary n-3/n-6 fatty acids and their relationship to obesity, type II diabetes and cardiovascular disease. **Dr. Picklo** was awarded the 2009 Herman Esterbauer Award for lipid peroxidation research. In October 2009, Pedro Del Corral joined the Grand Forks Human Nutrition Research Center as a Research Physiologist. Most recently, he

was a Post-Doctoral Scholar in the Department of Nutrition Science and an Assistance Instructor in the Department of Biology at the University of Alabama, Birmingham. 
